1. Call to Order

Dermot called the meeting to order at 7:09pm.

2. Approval and Additions to Agenda

Approval of Agenda with no additions. All in favour.

3. Review and approval of the draft Minutes from April 14th

Review and approval of the draft minutes from April 14th 2020 after a few minor corrections were noted and made by Craig. Moved by Jonathan and seconded by Stuart. All in favour.

4. Snowmaking Proposal and Discussion: Alain Masson_

Snowmaking at WCCSC is time consuming for CCY staff (primarily Alain) and this coming year Alain may be the only CCY staff member.

An early season snow loop at Mt. Sima is being proposed.

Early November training would be possible at the Mt. Sima location as the location is a north facing area with a colder micro climate than the WCCSC south facing stadium where the ski club currently must make snow. On average the location at Mt. Sima is about 3 to 4 degrees colder in November. Approximately 3 to 4 weeks of early season training could occur at Mt. Sima before similar conditions are ready at WCCSC.

Mt. Sima has a dedicated staff for snowmaking as it is essential to their operation. Mt. Sima also has good equipment and expertise.

A snow loop at Mt. Sima could be made for approximately \$10 000.00.

It is proposed that snow loop passes will be sold for about \$75.00. If 135 passes are sold there will be cost recovery.

The CCY snowmaking equipment would remain at WCCSC for most of the year but be taken to Mt. Sima to supplement Mt. Sima's equipment for the late October or early November cross country loop snowmaking.

It is possible that in future years if the loop is successful that outside cross country ski teams could come to St. Sima to train as some downhill ski teams do.

No YESAB application is required as the proposed loop (at least for this coming season) is on Mt. Sima tenured land.

The WCCSC board was supportive of the proposal and Dermot will write a letter stating so. The letter will also mention that WCCSC does have an interest in a long term snowmaking plan at the Nordic Centre or at another location under the control of WCCSC however WCCSC is not currently ready to undertake this initiative.

Stuart Hamilton mentioned that the Mt. Sima snow loop proposal will be an interesting experiment to determine how much interest there is in an early season snow loop operating with a user pay model.

6. Meeting with CCY_Ski Nationals bid

The board was in agreement that enthusiasm for bidding for the 2021 Ski Nationals which Sovereign Lakes has declined to host has been curtailed by COVID-19 concerns and the strong possibility that there will not be a 2021 Ski Nationals.

7. Policy Governance committee

The committee is progressing with its work and Marcus reported that it is reasonable to believe that a policy book will be ready for the start of the 2020-2021 ski season.

8. Strategic Planning committee

Jean Paul was asked by CDF if the required reporting on the Strategic Planning Funding could be completed by June 30th. Jena Paul inquired with Travis Armour of Strategy North and learned that July 31st was more realistic. Jean Paul communicated this diary date to CDF and it was accepted. The reporting agreement will be amended.

Jan has sold two club snowmobiles and will be selling one more.

The large gas tank and diesel tank in the PB shed are being replaced this spring.
