MINUTES OF THE MEETING

4.3 Motion to appoint Ben Robinson as the WNSS accountant for the 2024/2025 fiscal year.

A question was asked about how WNC contributes to snowmaking. Jan responded that there is an MOU between WNC and CCY. Under the MOU, WNC contributes by moving the snow and grooming in the stadium after the snow is made.
